 (\*) number of days on which the highest 8-hourly mean ozone concentration of 120 µg/m<sup>3</sup> has been exceeded in at least one measuring station in Belgium, calculated in accordance with the restrictions of the EU Directive 2008/50/EC.

This indicator provides no information on the scope or the duration of the excess. The reported number of days depends in fact on the number of monitoring stations, and thus excludes any comparison between periods or regions with a different density of monitoring stations.
